The Indian Council of Forestry Research and Education (ICFRE, an Autonomous Body of the Ministry of Environment, Forests and Climate Change, Government of India invites applications from the eligible officers under Central/State/Public Sector Undertakings/ Autonomous Bodies/Statutory organization for filling up 12(Twelve) posts of Forest Range Officer on deputation including short terms contract in under mentioned Institutes of ICFRE in the Pay Scale at Level 7 of Pay Matrix plus usual allowances as admissible under rules in ICFRE:

The above vacancies may either be decreased or increased in any Institute subject to variation dependent on workload.

Eligibility: Analogous posts
OR
Deputy Ranger in the pay level 6 of 7th CPC Pay Matrix with 5 years of regular service in the grade
OR
Foresters in the pay level 4 of 7th CPC Pay Matrix with 15 years of regular service in the grade.

Tenure: The tenure shall ordinarily be 3 years or till superannuation, whichever is earlier. The tenure is, however, liable to be terminable at an earlier date or extendable at the discretion of appointing authority/cadre controlling authority.

General Instructions:

1. 4. In no case the Council will be responsible for non-receipt of application or any delay in receipt thereof on any account whatsoever. No application received after the stipulated last date will be entertained under any circumstances and all the late applications will be summarily rejected.
5. The candidate must submit their application through proper channel. The concerned department/organization should enclose vigilance clearance report and Annual Confidential Reports of the officer for the last five years (2014-15 to 2018-19) while forwarding the applications of the candidates. However, an advance copy can be submitted along with the prescribed fee.
6. The Council reserves the right to relax, the qualifications/experience in case of exceptionally qualified and meritorious candidates.
