ORDER

Ministry of Environment, Forests & Climate Change, GOI Regional Office, Gandhinagar vide letter dated 28.01.2026 has conveyed its approval for diversion of 0.1855 hac. forest land in favour of M/s Hindustan Petroleum Corporation Limited for Construction of Approach Access for Proposed Hindustan Petroleum Corporation Limited Retail Outlet on Sikar to Bikaner Road NH-52(Old NH-11) RHS on Khasra No-261/260, Chainage 410/120 to 410/155, At Bhojdeshar, Tehsil – Ramgarh Shekhawati, District – Sikar (Rajasthan) FP/RJ/PetrolPump/542243/2025. In pursuance of the above clearance by Govt. of India, State Government hereby accords approval under Section 2 of the Forest (Conservation) Act 1980 with the following conditions:-

1. The conditions imposed by MoEF&CC, Gol in their forest clearance dated 28.01.2026 will be complied with by all concerned.
2. This order along with conditions imposed by the Central Government according to stage I and stage II clearance are mandatorily required to be displayed on the website by State Forest Department as well as by MoEF&CC, Gol.
3. The project proponent should publish the entire forest clearances granted in verbatim along with the conditions and safeguards imposed by the Central Government in Forest Clearance in two widely circulated daily newspapers, one in Hindi and the other in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forestry purposes.
4. The copies of the Forest clearance should also be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn have to display the same for 30 days from the date of receipt.
5. Action as per Para 1.21 (ii) of the handbook of guidelines of FCA, 1980 may be ensured & Final outcome may be intimated.
6. Any other condition as and when imposed by State Government.
