आपको विदित है कि RIDF-XVIII के अन्तर्गत नाबार्ड के सहयोग से "Project for Development of Water Catchment Through Greening of Rajasthan" प्रदेश के 17 जिलों में वर्ष 2012-13 से क्रियान्वित की जा रही है। इसी क्रम में इस परियोजना के द्वितीय घरण (Phase-II) के प्रस्ताव राज्य सरकार के माध्यम से नाबार्ड को वित्त पोषण हेतु प्रस्तुत किए गए हैं। जिनकी स्थीकृति शीघ्र प्राप्त होने की उम्मीद है। परियोजना के द्वितीय चरण में प्रस्तावित कार्यों का विवरण परिशिष्ट-1 पर संलग्न है। इस परियोजना के क्रियान्वयन के सम्बन्ध में अतिरिक्त मुख्य सचिव (इन्फा) की अध्यक्षता में दिनांक 24.01.2014 को एक बैठक आयोजित की गई थी। जिसमें लिए गए निर्णय की प्रति परिशिष्ट-2 पर संलग्न है। फेज-ा के क्रियान्वयन के सम्बन्ध में राज्य सरकार के स्तर पर लिये गये निर्णय अनुसार परियोजना की गतिविधियों को वाटर शेड के आधार पर जलग्रहण एवं मूँ-संरक्षण विभाग द्वारा स्वीकृत एवं वर्तमान में चल रहे जलग्रहण परियोजनाओं में स्थित वन क्षेत्रों में प्राथमिकता पर लिये जाने का निर्णय लिया गया है ताकि परियोजना के कार्यों का जलग्रहण विभाग द्वारा संचालित जलग्रहण परियोजना से कन्वरजैन्स स्थापित हो सके। बैठक में यह भी निर्णय लिया गया है कि जलग्रहण विभाग द्वारा दी गई जानकारी के अनुसार स्थीकृत जलग्रहण परियोजनाओं के क्षेत्र में स्थित वन क्षेत्रों में फेज-ा परियोजना अन्तर्गत लिये जा सकने योग्य कार्यों का विस्तृत विवरण विभाग द्वारा तैयार कर जलग्रहण विभाग को उपलब्ध कराया जाना है ताकि आपसी सम्बन्ध से कार्य सम्पादित करने की प्रक्रिया स्थापित की जा सकें। इन कार्यों को जिला कलक्टर की अध्यक्षता में गठित जिला स्तरीय जलग्रहण समिति द्वारा भी नियमित तौर पर समीक्षा की जावेगी।

In reference to above subject, a meeting was held under the chairmanship of ACS (Infra) in respect of directions by the State Government for convergence during the implementation of Integrated Watershed Management Project (IWMP) of the Watershed Department and the proposed NABARD assisted project of the Forest Department.

I am directed to request you to take the following actions as decided in the said meeting to establish effective convergence between the Forest and Watershed Departments in the field:-

1. The Watershed Department will provide to the Forest Department districtwise list of watersheds sanctioned by them showing therein the forest areas.

The Forest Department will examine the feasibility of undertaking developmental works in the forest areas so identified under the projects sanctioned in the Watershed Department.

2. The Forest Department will furnish a list of such areas which can be treated by them along with particulars regarding date of commencement of works, date of completion of treatment etc. to the Department of Watershed.

3. The District Level Officer (DLO) of the Department of Watershed would, upon receipt of the list from the Forest Department, furnish it before the District Level Watershed monitoring Committee headed by the Collector with Dy. Conservator of Forest its member. This item would be on the permanent Agenda of the Committee and would be reviewed from time to time.

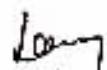

5. At the State Level, the State Level Nodal Agency of the Watershed Department, which has a representative of the Forest Department in it, will monitor the progress of convergence between the Watershed Department and the Forest Department in the field.
6. A Nodal Officer in both Watershed and Forest Department may be nominated by Director, Watershed Department and PCCF to formulate common guidelines for establishing convergence and prescribing reporting formats for both departments.

Further, the project submitted by the PCCF for development of Water Catchment Through Greening of Rajasthan amounting to Rs.283.42 crores to be implemented between 2013-14 to 2018-19 in 17 districts of the State has been forwarded to the Finance Department to be submitted to NABARD for sanction. As per decision taken at the State Government level, convergence should be established between this programme and the IWMP of the Watershed Department. As per decision taken as above in the meeting on 24/1/2014, the Watershed Department would identify the IWMP sanctioned watersheds in the 17 districts and furnish the same to the Forest Department who would undertake treatment works in the forest areas of these IWMP watersheds under the NABARD assisted project. Two existing committees at the State and District levels as mentioned above would periodically monitor the progress of convergence. Kindly ensure compliance for above by issuing detailed instructions to your subordinate officers from your level.
