


कार्यालय आदेश

राज्य सरकार के आदेश क्रमांक प.5(3)कार्मिक/क-1/2019 दिनांक 31.01.2019 से अधोहस्ताक्षरकर्ता को प्रधान मुख्य वन संरक्षक (एच.ओ.एफ.एफ), राजस्थान जयपुर का कार्यभार दिया गया है। कार्यभार ग्रहण किये गये लगभग डेढ़ माह की समय अवधि में विभिन्न पत्राचार एवं विभाग के अधिकारियों से बात चीत से यह महसूस किया गया है कि राज्य सरकार के आदेश क्रमांक प. 12(59)वन/2016 दिनांक 01.10.2018 जो कि प्रमुख शासन सचिव, वन विभाग द्वारा जारी किया गया है, के दिशा-निर्देशों की पालना नहीं की जा रही है।

1. जैसा कि मुख्यालय पर स्थित अधिकारियों अथवा फील्ड स्तर के अधिकारियों द्वारा भी प्रधान मुख्य वन संरक्षक (अधोहस्ताक्षरकर्ता) को समय पर सही रूप से ब्रीफिंग नहीं किया गया है, और न ही सूचना/जानकारी उपलब्ध करायी गयी जिसके कारण से राज्य सरकार को वन विभाग के संबंध में सुझाव देने/सूचनाएं प्रस्तुत करने में कठिनाई उत्पन्न हो रही है।
2. अतिरिक्त प्रधान मुख्य वन संरक्षक एवं मुख्य वन्यजीव प्रतिपालक, राजस्थान जयपुर को भी यह विशेष रूप से आदेशित किया गया था कि प्रधान मुख्य वन संरक्षक (एच.ओ.एफ.एफ) को वन्यजीव प्रभाग से संबंधित समस्त विषयों के बारे में समय-समय पर अवगत कराते रहेंगे परन्तु वन्यजीव शाखा द्वारा भी अधोहस्ताक्षरकर्ता को मुख्य एवं अतिआवश्यक विषयों की जानकारी नहीं दी गयी है।

ORDER

In Super-session of order No. 12(9)Forest/2006 dated 12th May, 2011 of this department regarding allocation of duties and responsibilities of Principal Chief Conservator of Forests, the Governor is pleased to direct that the distribution of work among the Principal Chief Conservator of Forests will hence forth be as follows:-

1. Principal Chief Conservator of Forests, (Head of Forest Force), Rajasthan

- i. The Principal Head of the Department and advisor to the state Government for the Forests Department.
- ii. Overall in-charge of the administrative and financial matters.
- iii. Overall in-charge of the planning, development, monitoring & evaluation of the projects/programs in the Department.
- iv. Coordination among the other Principal Chief Conservators of Forests.

2. Principal Chief Conservator of Forests, Development

- i. Assisting PCCF (HOFF) on the matters related to budget allocation, supervision, monitoring, formulation and implementation of CSS Schemes, Externally aided projects as well as schemes/project implemented by PCCF & CWLW and PCCF WP&FS.
- ii. Assisting PCCF (HOFF) in implementation of Forest Protection & FCA in the State along with supervision of activities under project formulation and coordination, monitoring and evaluation, Employment Guarantee Scheme, Rajasthan Forestry and Biodiversity project.
- iii. Management of Training, Research, Extension and Education Programs

3. Principal Chief Conservator of Forests & Chief Wildlife Warden

- i. Discharge of duties and responsibilities assigned under various Acts related to Wild Life and Protected Areas for effective implementation of Acts and management of Wild Life.
- ii. Supervision and management of all Wild Life Sanctuaries, National Parks, Protected Areas, Biological Parks and Zoos as well as wildlife outside the protected Areas.
- iii. Formulation & Implementation of Wild Life Conservation Projects and promotion of Wild Life research in the State.
- iv. Liaisoning with Wild Life Institute of India and other institutions working for wild life conservation & research.
- v. Functioning and supervision of various Foundations, Authorities and Societies related to wild life conservation and management.
- vi. Promotion of Eco-Tourism activities in the State.

4. Principal Chief Conservator of Forests, Working Plan & Forest Settlement

- i. Preparation and implementation of working plan in the State.
- ii. Forests settlements and updation of entries of forest lands in revenue records.
- iii. Notification of forest lands as per classification, namely, reserve forests/ protected forests.
- iv. Supervision of all activities of Departmental Operations in the State.
- v. Management of Tendu Patta in the State.
- vi. Promotion of medicinal plants in the State.
- vii. Promotion of Information Technology (IT) in Forestry Sector.
- viii. Formulation and implementation of Schemes for soil conservation in the catchment areas of River valley projects and Flood Prone Areas.
- ix. Monitoring of Wood Based Industries (Establishment & Regulation) Guidelines in the State.

The order allocating the duties and responsibilities to the officers posted within the administrative control of PCCF (HOFF), PCCF & CWLW and PCCF WP&FS will be issued by the Concerning PCCF, However, in the matters concerning more than one PCCF, orders shall be issued by PCCF (HOFF).

For the Disposal of work through Single File System, all the PCCFs will route their files through PCCF (HOFF)

These orders will come into force with immediate effect.


