In exercise of the powers conferred by second proviso to rule 2 of the Rajasthan Forest (Produce Transit) Rules, 1957, the State Government hereby makes the following amendment in this department's notification No. F.15(33)Forest/98 dated 02.09.06; namely:-

AMENDMENT

In the said notification, in proviso (i), the existing expression "districts of Sri Ganganagar, Hanumangarh, Bikaner, Jaisalmer and Phalodi and Osian Tehsils of Jodhpur district," shall be substituted by the following; namely:-

"following areas:-

- (a) Bikaner district;
- (b) Jaisalmer district;
- (c) Sri Karanpur, Raisinghnagar, Wijainagar, Anupgarh, Suratgarh and Gharsana Tehsils of Sri Ganganagar district;
- (d) Hanumangarh, Tibi, Pilibanga, Rawatsar, Nohar and Bhadra Tehsils of Hanumangarh district;
- (e) Phalodi and Osian Tehsils of Jodhpur district."
