NOTIFICATION

In exercise of the powers conferred by section 41 of the Rajasthan Forest Act, 1953 (Act No. XIII of 1953), the State Government hereby makes the following rules further to amend the Rajasthan Forest (Produce Transit) Rules, 1957, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Forest (Produce Transit)(Amendment) Rules, 2016.

(2) They shall come into force with immediate effect.

2. Amendment of rule 3.- In sub-rule (2) of rule 3 of the Rajasthan Forest (Produce Transit) Rules, 1957, hereinafter referred to as the said rules, after the existing clause (f), the following new clauses (g), (h) and (i) shall be added, namely:-

“(g) Description of origin of forest produce.

(h) Type and registration number of vehicle used in transportation of forest produce.

(i) Details of Fee paid for the pass.”

3. Amendment of rule 4.- In rule 4 of the said rules, the existing expression “payment of a fee of rupee one.” shall be substituted by the following, namely:-

“payment of a fee, in case of transportation by, -

(i) non-mechanised vehicle (Cycle, Bullock Cart, etc.) shall be rupees ten.

(ii) light motor vehicle or tractor trolley shall be rupees one hundred; and

(iii) any kind of truck, trailer truck or other heavy motor vehicle shall be rupees one thousand.”

4. Substitution of Form-I.- The existing Form-I appended to the said rules, shall be substituted by the following, namely:-
