Sir,

In reference to the meeting held by Chief Secretary with ACS, Forests & Principal Secretary, Revenue on 29/8/2012, you are requested to take the following action:-

- 1. Copy of notifications of forest land should be compiled forest division-wise and be furnished to concerned district Collectors. A composite set in soft copy should be made available to Revenue Department. These informations should be sent with covering note. In the covering note, it must be mentioned that such land can't be used for non-forestry purposes without permission from GoI.
- Copy of Kapoor Committee report filed by the State Government with affidavit in Supreme Court must be furnished to all Dy. CFs (Territorial/WL), Collectors and Revenue Department with the extract of 1996 Judgement making the position of applicability of FCA clear. It should also be placed on website along with specific mention of applicability of FCA.
- 3. Copy of notifications for sanctuaries/National Parks/Tiger Reserves should be compiled and be given to Collector / Revenue Department conveying that the land falling within the notified limits can't be used for non-forestry purposes without permission from Hon'ble Supreme Court if it is private land and Hon'ble Supreme Court & GoI if it is forest land.

REPORT OF THE EXPERT COMMITTEE

Govt. of Rajasthan Constituted State Level Expert Committee vide letter no. 18(162) Forest / 96 Jaipur dated 5th Oct., 2002 in pursuance of the direction of Central Empowered Committee constituted by the Hon'ble Supreme Court in writ petition no. 202/95 in T.N. Godavaraman v/s. Union of India and others, for reidentification of areas which are to be treated as Forests as per order dated 12.12.96 of Apex Court. The committee was constituted as follows under the Chairmanship of Addl. Pr. Chief Conservator of Forests, Arawali Afforestation Project, Rajasthan, Jaipur:-

The Committee was assigned the following tasks:-

- 1. Identify areas which are "Forests" of whether they are so notified, recognised or classified under any law, and irrespective of the ownership of the land of such forests.
- 2. Identify areas which were earlier forests but stand degraded, denuded or cleared, and
- 3. Identify areas covered by plantation / trees belonging to the Govt. and those belonging to the private persons.
- 4. To identify the sacred groves such as Orans, Banis, Dev-vans etc. so that these areas could be placed in the category of Forests.

A sub-committee was also constituted for each district to assist the above committee as follows:-

- (i) D.F.O. / D.C.F.
- (ii) S.D.O.
- (iii) Tehsildar

After in depth discussions in the first meeting held on 28.10.2002, detailed guidelines were issued to the concerned officers (C.Fs & D.C.Fs.) for identification of the areas and different proforms were devised for collecting the information from various districts and circulated to all the concerned officers.

Information with regard to different categories of forests as per guidelines was collected as per the details given below:-

- 1. Legally notified forest areas as Reserved, Protected and Un-classed in Annexure-I.
- Areas recorded as forest in the Govt. records in Annexure-II.
 These lands are recorded as Ge. Mu. Pahad / Billa Naam Sarkar / Village Forest / Gochar / Private Forest / Sewai Chak etc. in the revenue records.
- 3. Deemed forest area as per the Oxford Dictionary meaning which defines forest as "a track of land covered with trees and under-growth", irrespective of ownership. For this purpose the committee decided the criteria of deemed forest as a compact area of minimum 5 ha. and where naturally growing minimum 200 trees per ha. exist. Information in this category was collected in Annexure-III.
- 4. The committee deliberated on the Term of Reference No. 2 regarding identification of areas which were earlier forests but stand degraded, denuded or cleared. It was felt that this information cannot be compiled for want of earlier records about the status of forests. The degradation and denudation of forests is a continuous process spread over a long period of time. Unless the baseline information is available it is not possible to clearly indicate the extent of areas which were earlier forests and now stand degraded / denuded. It is only possible to give the current status of forest cover by using Satellite data by adopting a system as adopted by the Forest Survey of India (FSI). The FSI has been making biennial assessment of the country's forest cover using Satellite data.

This is a time consuming exercise and beyond the scope of the Expert Committee. Thus this information has not been given in the report.

- 5. Information regarding plantations raised by the Forest Department, other Govt. Departments / Institutes and private individuals on non-forest lands such as revenue / panchayat / other department / institutions and private individuals was complied in Annexures IV, V & VI respectively.
- 6. The information regarding sacred groves—Orans, Dev-vans, Banis etc., was compiled in Annexure-VIIA and VIIB with regard to areas recorded as forests in government records and areas in deemed forests category as per expert committee guidelines respectively. The details correspond to information compiled in Performa A (Annexure-III) and Performa B (Annexure-III).

The abstract of different categories of forest areas is given in the table-I below:-

The question whether plantations on non-forest land are to be treated as forest or not was deliberated in committee meeting at length in view of various Supreme Court decisions. Logical conclusion of the analysis made by the committee was that the plantations on non-forest land are not to be treated as forest.

A brief of the analysis made is as under :-

The Hon'ble Supreme Court in its order dated 12.12.1996 in the writ petition (Civil) No. 202 of 1995 T.N. Godaverman versus Union of India and other has defined the term "Forest" and also forest land with reference to Section 2 (i) of the Forest (Conservation) Act, 1980. According to this, "the word "Forest" must be understood according to its dictionary meaning. This description covers all statutorily recognised forest whether designated as reserved/protected or otherwise for the purpose of Section 2(i) of the Forest (Conservation) Act. The term "Forest land", occurring in section 2, will not only include forest as understood in the dictionary sense, but also any area recorded as forest in the Govt. record irrespective of the ownership. This is show it has to be understood for the purpose of Section 2 of the Forest Conservation Act." In Oxford dictionary, the meaning of the term "Forest" has been given as "a large tract covered chiefly with trees and undergrowth". In Bhargava's dictionary the meaning of the term "Forest" has been given as "a large tract of land covered with trees and extensive wood". Here, the Hon'ble Supreme Court has meant only those tracts which are covered with

natural trees and undergrowth as "Forest" and not the tract which are covered with plantation trees. That is why the Hon'ble Supreme Court has ordered the expert committee constituted by the State Govt. under para 5 of the decision to identify the areas covered by plantation trees belonging to the Government and those belonging to the private persons in a category other than "Forests". This intention of the Hon'ble Supreme Court is further clear from para II (I) of the decision in respect of the State of Jammu-Kashmir where Hon'ble Supreme Court has directed as under:

"There will be no felling of trees permitted in any "forests", public or private. This ban will not affect the felling in any private plantations comprising of trees planted by private persons or the Social Forestry Department of the State of Jammu-Kashmir and in such plantations felling will be strictly in accordance with law".

Here the term "Forest" used by Hon'ble Supreme Court means the "Forest" defined by the Hon'ble Court, but they have made it clear that the "Forest" does not include private plantations or plantations under Social Forestry.

The intention of the Hon'ble Supreme Court of not including the tree plantations in the term "Forest' is also clear from their order in para III(I) of the judgment for the State of Himachal Pradesh and hill regions of State of U.P. and W.B. which is as under:-

"There will be no felling of trees permitted in any forests public or private. This ban will not affect felling in any private plantations comprising of trees planted in any area which is not a "forest" and which has not been converted from an earlier "forest".

Thus, it is very clear that the term "Forest" defined by Hon"ble Supreme Court does not include man-made plantations. Hence a tree plantation on a non-forest land, which was not earlier forest and has not been recorded as forest, does not attract the provision of the Forest Conservation Act, 1980. This has further

been made more clear by the Hon'ble Supreme Court in its decision dated 12.5.2001 in I.A. No. 295 in WP(C)202 of 1995 T.N. Godaverman versus Union of India and others. The relevant portion of the order is as under.

"Felling of trees from forest shall be only in accordance with the working plans/schemes or felling schemes approved by Ministry of Environment and Forests as per this court's order dated 15.1.99. It is again clarified that such working plans, schemes shall also be needed for felling of trees from any Non-Govt. forest area including the land which are required to be treated as "Forest" as per this court's order dated 12.12.96. While implementing the working plans/schemes approved by the Central Government, State Government or the concerned authority, as the case may be, shall ensure that no felling is done unless and until sufficient provisions exists for regeneration of such areas as per this court's direction dated 22.9.2000. For felling of trees from non-forest area including in respect of plantation on non-forest area, detailed guidelines/rules shall be framed by the concerned State Govt., which shall come into effect after the same are concurred with modification, if any, by the Ministry of Environment and Forests".

Though this direction is for the North-Eastern States, but it is amply clear that the term "Forest" does not include plantation on non-forest land.

From the above, it is clear that the tree plantation on non-forest land are not to be treated as "Forest" as defined by the Hon'ble Supreme Court in its order dated 12.12.96.

The plantations raised by the different departments on Revenue, Panchayat and other Departments / Institutions and Private Individual lands need to be managed as per provisions of Management Plan prepared for the purpose. However, the State Government may consider transferring the old plantations raised on the Revenue land and other category plantations could be managed by the respective Departments / Institutions as per management plans technically approved by the concerned DFO's / Dy.CF's in whose jurisdiction such plantations are situated.

The Pr. Chief Conservator of Forests, Raj. Jaipur vide his letter no. F16 (Sup. Court) / 97 / FP / PCCF / 1069 dated 27.1.2004 also desired that the Expert Committee should also consider the letter no. II / FC / ROC / 95-2002 dated 28.1.2003 and No. II / FC / ROC / 95-2002 (part II) / 346 dated 15.4.2003 of Govt. of India, Ministry of Environment and Forests, Regional Office, Lucknow with regard to the following 5 categories of the lands:-

- 1. Gair Mumkin Pahar.
- 2. Gair Mumkin Rada.
- 3. Gair Mumkin Behed
- 4. Banjad Beed
- 5. Rundh

The committee considered the above five categories of lands in the state within the overall framework of Hon'ble Supreme Court order of 12.12.96 and also the guidelines framed by the Expert Committee for re-identification of forest areas. Out of these whichever areas fulfilled the guidelines have been included in the deemed forest categories mentioned above in table-I.
