Notification

In exercise of the powers conferred by section 26A and 76 of the Rajasthan forest Act, 1953 (Act No. 13 of 1953), the State Government hereby makes the following rules further to amend the Rajasthan Forest (Settlement) rules, 1958, namely:-

1. Short title and commencement.- (1)These rules may be called the Rajasthan Forest (Settlement) (Amendment) Rules 2023.

(2) They shall come into force with immediate effect.

2. Amendment of Rule 6.- In rule 6 of the Rajasthan Forest (Settlement) Rules, 1958, the existing following expression,-

"Outer Boundary Pillars (Masonry).- The overall height above ground should be 2'-9". The top 9" of the pillar should be a pyramid. The sides should be 18" square with a stone engraved number plate, painted over with black Japan on a white enamel background. The pillar must be white" shall be substituted by the following expression, namely:-

"Outer Boundary Pillars (Masonry).- Height of Outer Boundary Pillar (Masonry) constructed after the commencement of the Rajasthan Forest (Settlement) (Amendment) Rules 2023, shall be 1.2 meter above the ground and length and width at bottom shall be 1.2 meter and shall be 0.45 meter each on top. The slanting/tapered part will be of 1.26 meter in slop. Depth and width under the ground shall be 0.3 meter and 1.2 meter respectively. Pillar number and FD shall be engraved on outer side of the pillar. The pillar above the ground shall be painted with white colour and the engraved part of the pillar shall be painted with red colour for highlighting."
