Sir,

In accordance with the provisions of Rule 16 of the All India Services (Conduct) Rules, 1968, Members of All India Service's are required to submit their Annual Immovable Property Return (AIPR) in the prescribed performa.

2. This ministry has developed a software in order to facilitate the Indian Forest Services (IFS) officers to file their Annual Immovable Property Return (AIPR) online. Accordingly, every IFS officer is required to submit his/her AIPR online at ifs.nic.in → Immovable Property Return → login, (User ID/Password). In case of any help, they may contact (Shri R. K. Pathak, Director, 011-24695407) NIC cell in the ministry.

3. While furnishing the AIPR, it may be ensured that usage of phrases such as "same as previous year" or "no change" need to be avoided and full particulars of the immovable property inherited/owned/acquired or held are to be furnished.

4. The AIPR is required to be submitted in respect of every calendar year by 31<sup>st</sup> January, of the following year. As such, the AIPR for the year 2015 (as on 01.01.2016) is to be submitted by 31<sup>st</sup> January, 2016.
