Naresh Chauhan Vs Union of India & Ors.

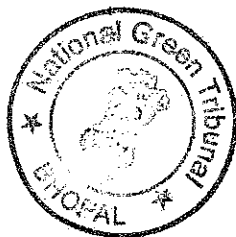
In compliance of order dated 02<sup>nd</sup> May, 2024 passed by Hon'ble Bench in  
Original Application No.90/2023(CZ) titled as Naresh Chauhan Vs Union of India &

"2. In view of the provisions contained in Section 2 of the Forest (Conservation) Act, 1980  
and notification issued by the MoEF&CC vide letter dated 30.11.2023, we direct that  
there must be strict compliance of the provisions of the Compensatory Afforestation  
Fund Act 2016, rules and guidelines made there under and State Government of  
Rajasthan must ensure that the funds from the CAMPA shall be utilised only for  
mitigation measures proposed under the project against which funds have been  
realised from the user of agency and under no circumstances these funds will be  
diverted for compensating the loss by allowing non-forestry use of plantation raised in  
the government and community lands. The communication and the decision taken by  
the MoEF&CC must be strictly observed with. Copy of this order with the notification  
dated 30.11.2023 (Annexure- R/2) of the application be forwarded to the (1) Chief  
Secretary, State of Rajasthan (2) The Principal Chief Conservator of Forest, State of  
Rajasthan and (3) DFO concerned, Forest Department, State of Rajasthan for  
compliance. The Action Taken Report with the report of the committee be filed within  
three weeks."

**ORDER**

1. Vide order dated 12.03.2024 in para 8 a committee was constituted to submit the report. The report is awaited. Learned Counsel for the Respondent sought a short time to file the reply. The same may be filed within three weeks.

In view of the provisions contained in Section 2 of the Forest (Conservation) Act, 1980 and notification issued by the MoEF&CC vide letter dated 30.11.2023, we direct that there must be strict compliance of the provisions of the Compensatory Afforestation Fund Act 2016, rules and guidelines made there under and State Government of Rajasthan must ensure that the funds from the CAMPA shall be utilised only for mitigation measures proposed under the project against which funds have been realised from the user of agency and under no circumstances these funds will be diverted for compensating the loss by allowing non-forestry use of plantation raised in the government and community lands. The communication and the decision taken by the MoEF&CC must be strictly observed with.
