

CHAPTER 1

Organisation of The Forest Department and Administrative Charges

1. Functions of the Forest Department:

- 1.1. The principal aim of the Forest department is to achieve environmental stability and ecological security through increasing vegetal cover. This is to be accomplished by meeting the following objectives¹:-
 - 1.1.1. Protecting, conserving and developing natural forests of Rajasthan with active participation of local community for ecological security of human society;
 - 1.1.2. Undertaking massive afforestation on Government, Community owned wasteland, privately owned agriculture and non-farm land for expanding the natural cover of the State both in rural and urban areas simultaneously to meet the timber, fuel wood and non-timber forest produce demands of the society;
 - 1.1.3. Increasing the productivity of Forests through appropriate management interventions and use of modern technology to meet the needs of present and future generations;
 - 1.1.4. Combating desertification (through shelterbelt plantations, block plantations, sand dune stabilization and Agroforestry in desert areas) and preventing all kinds of land degradation;
 - 1.1.5. Meeting the livelihood needs of tribal and other forest dependent communities by reducing their dependence on natural resources by development of proper facilities of processing, grading, value addition and marketing particularly of non-timber forest produce;
 - 1.1.6. Conserving floral and faunal diversity and gene pool reserve through a network of protected areas, such as National Parks, Sanctuaries, Conservation reserves and Community Reserves;
 - 1.1.7. Conserving rare and endangered species of flora and fauna of the

state by undertaking *in-situ* and *ex-situ* conservation measures, apart from conserving and managing biodiversity-rich ecosystems such as grasslands, orans and wetlands etc.;

- 1.1.8. Empowering the village communities for sustainable management of forest under Joint Forest Management System;
- 1.1.9. Strengthening forestry research base for enhancing productivity of forest and promoting better utilization of forest produce;
- 1.1.10. Disseminating and extension of research finding and proven technologies for adoption by the users and providing support services to the farmers for promotion of agro-forestry;
- 1.1.11. Instituting human resource development through a proper system of career planning, upgrading of technical and professional skills of forestry personnel, villagers and other important stakeholders and
- 1.1.12. Shifting the focus from traditional management practices to people oriented approaches by internalizing intensive and extensive participatory strategies in the working system of the Forest Department to make it peoples' movement with the increasing involvement of women.

2. General Administration

- 2.1. Principal Chief Conservator of Forest (Head of Forest Force) is the head of the Forest Administration in the State. He is the chief advisor to the Government in matters related to Forests.
- 2.2. There are three officers in the rank of Principal Chief Conservator of Forests namely the Principal Chief Conservator of Forests and Chief Wild Life Warden, Principal Chief Conservator of Forests, Working Plan and Forest Settlement, Principal Chief Conservator of Forests (TREE).
- 2.3. The Principal Chief Conservators of Forests report to the Government directly on the policy issues concerning subjects allocated to them keeping the Principal Chief Conservator of Forests (HoFF) apprised². Addl Principal Chief Conservator of Forests (Administration), Addl Principal Chief Conservator of Forests (Head Quarter), Addl Principal Chief Conservator of Forests (Labour and Law) and Addl Principal Chief Conservator of Forests, Project Formulation and Co-ordination directly report to him. The Addl Principal Chief Conservator of Forests (Administration) is assisted by Chief Conservator of Forests (Estt), Chief Conservator of Forests and TA to PCCF. Similarly the Addl Principal Chief

Conservator of Forests (Head Quarter) is assisted by the Chief Conservator of Forests (HQ).

- 2.4. The PCCFs also allocate duties to the officers posted within their administrative control to perform duties allocated to them.
- 2.5. Principal Chief Conservator of Forest (TREE) is responsible for management of Training, Research, Extension and Education Programs in the State besides implementation of Forest (Conservation) Act 1980 and deals with matters related to forest protection. He also oversees formulation and implementation of Centrally Sponsored and the Externally Aided Schemes except schemes related to Wild Life management. He is assisted by Addl Principal Chief Conservator of Forests (Development), Addl Principal Chief Conservator of Forests, (Forest Protection), Addl Principal Chief Conservator of Forests and Nodal Officer (Forest (Conservation) Act, 1980), Addl Principal Chief Conservator of Forests (M&E), Project Director, RFBP Phase II, a Chief Conservator of Forest (R&T) and a Financial Advisor. All the Regional Chief Conservators of Forests directly report to the Addl Principal Chief Conservator of Forests (Development).
- 2.6. The Financial Advisor is the chief advisor to the PCCF (HoFF) in all the finance related matters. He reports to him through the PCCF (TREE).

3. Forest Management

- 3.1. The entire area of the State has been divided into 7 regions for efficient management of Forests. These regions are co-terminus with the revenue administration. Each region is managed by a Chief Conservator of Forest. He is assisted by a Conservator of Forests (M&E), a Deputy Conservator of Forest (Admn) and invariably an Asstt Conservator of Forests, an AFSO and sometimes a flying squad is also placed at his disposal besides the ministerial staff. A Deputy Conservator of Forests (P&M) and a WPO are also stationed in his office although they report directly to the Conservator of Forests (M&E) and Chief Conservator of Forests (Working Plan) respectively.
- 3.2. Each region is further divided into territorial divisions which are generally co-terminus with the districts but the bigger districts or where the quantum of development works is high, a district may have more than one division e.g. in Udaipur, Jaipur, Bikaner and Jaisalmer.
- 3.3. Presently the position of officers posted in the Regional offices and the details of Divisions under their control is as under:-

3.4. The area of a division is further divided into “Range”, “Section” and “Beat”. The incharge of these units is the Range Officer, Forester and a Forest Guard respectively.

3.5. The Principal Chief Conservator of Forests (Earlier CCF) may sanction the formation or redistribution of Ranges but alteration in administration or controlling charges and the creation or abolition of such charges require the sanction of Government³. The Chief Conservators of Forests (Earlier CF) may sanction the formation and redistribution of beats, and define the respective jurisdiction⁴.

4. Wildlife Administration

4.1. Principal Chief Conservator of Forests and Chief Wild Life Warden is

responsible for management of Wild Life administration in the State. He is also the Chief Wild Life Warden under the Wild Life (Protection) Act, 1972.

- 4.2. The Principal Chief Conservator of Forests and the Chief Wild Life Warden is assisted by an Addl Principal Chief Conservator of Forests (Wildlife), Chief Conservator of Forests (Wild Life), Chief Conservator of Forests, Eco-tourism, Deputy Conservator of Forests, (Plan), Deputy Conservator of Forests (Admn) and Asstt Conservator of Forests, Eco-tourism in his office.
- 4.3. There are five Chief Conservators of Forests (Wild Life) posted in Jaipur, Bharatpur, Udaipur, Jodhpur and Kota. They are responsible for supervising the Wild Life management in the areas falling in the jurisdiction of officers mentioned under each:-

5. Working Plans

- 5.1. The Principal Chief Conservator of Forests, Working Plan and Forest Settlement is also supervising preparation of working Plans and working schemes for the Forest and non-forest areas. The Addl Principal Chief Conservator of Forests (Production) assists him in discharge of his Working Plan related responsibilities.
- 5.2. The Chief Conservator of Forests, WP & FS supervises the work of preparation of these Plans and Schemes through the WPOs posted in the Regional CCF offices.
- 5.3. Chief Conservator of Forests, Information Technology reports to the Principal Chief Conservator of Forests, Working Plan and Forest Settlement through the Addl Principal Chief Conservator of Forests

(Production). The Conservator of Forests, Medicinal Plants who oversees the project implemented by the National Medicinal Plant Board also reports to him through the Chief Conservator of Forest, NTFP and Addl Principal Chief Conservator of Forests (Production).

6. Departmental Operations

- 6.1. Principal Chief Conservator of Forests, Working Plan and Forest Settlement assisted by the Addl Principal Chief Conservator of Forests (Production) is responsible for harvesting of Timber, fuelwood, Bamboo and Tendu Patta in the State.
- 6.2. The Chief Conservator of Forests, DOC supervises the harvesting of all Timber, fuelwood and Bamboo in the State through the five Divisions placed at his disposal and headquartered at Jaipur, Udaipur, Bikaner St I, Bikaner St II and Suratgarh. The Divisions are headed by the Deputy Conservator of Forests level officers.
- 6.3. Tendu Patta Collection in the State is overseen by the Chief Conservator of Forests, Tendu Patta. The auction of Tendu Patta bearing areas divided into small units and notified by the state Government every year is organized at the Regional level by the Regional Chief Conservators of Forests.
- 6.4. Other minor forest produce is collected by the contractors appointed through the process of open auction by the concerning Deputy Conservators of Forests.

7. River Valley projects

- 7.1. Formulation and implementation of schemes for soil conservation in the catchment of River Valley and Flood Prone Areas of Rajasthan entrusted to the Principal Chief Conservator of Forests, Working Plan and Forest Settlement. He oversees these projects through the Addl Principal Chief Conservator of Forests (Soil Conservation). There are two Chief Conservators of Forests headquartered at Jaipur and Kota for supervising the formulation and execution of these projects.
- 7.2. Presently the Chief Conservator of Forests, FPRP Jaipur has four field units which are headed by the Soil Conservation Officer, Sawai Madhopur, Soil Conservation Officer, Bhilwara, Deputy Conservator of Forests (Project) Tonk and Soil Conservation Officer, Sojat. Likewise the Chief Conservator of Forest RVP Kota has three units under his control. These are under the control of Deputy Conservator of Forests (Project) Banswara, Deputy Conservator of Forests (Project) Abu Road (Sirohi) and Deputy Conservator of Forests (Project) Begun.

8. Rajasthan Forestry and Biodiversity Project (RFBP) Phase II

8.1. The RFBP Phase II Project is being implemented in societal mode and the Project Director who is in the rank of Addl Principal Chief Conservator of Forests is the Chief Executive of the project. In the department it is monitored by the Principal Chief Conservator of Forests (TREE). The PD is assisted by two Addl Project Directors of Chief Conservator of Forests rank and a Joint Director in the rank of Conservator of Forests.

9. Research and Training

9.1. Chief Conservator of Forests, Training, Jaipur deals with management of training and education programmes and liaises with other training institutes of the country. The Chief Conservator of Forests, Research is the overall incharge of all the research activities in the State.

9.2. There are three training Schools one each at Jaipur, Alwar and Jodhpur. Every school is headed by a Deputy Conservator of Forests, Training. Deputy Conservator of Forests, Research is responsible for undertaking research under the guidance of Conservator of Forests, Research.

10. Revision in nomenclature of various posts in the Forest Department

10.1. The Government of Rajasthan have recently issued orders⁵ for redesignating various posts of Deputy Conservator of Forests level in the department. The details of posts rechristened are as under:-
