

CHAPTER 42

Rules¹ for The Management and Occupation of Forest Rest Houses

1. These Rules are for the maintenance and occupation of all Forest Rest Houses in Rajasthan. A list of such rest houses is attached herewith.
2. The forest Rest Houses is a Forest Department building. The Divisional Forest Officer of the Division will be directly responsible for the entire management, care and maintenance of the grounds and buildings and all its equipment.
3. The Forest Department will repair the building and houses and maintain the approach road, the wells the gates, walls and fences.
4. The Divisional Forest Officer will see that the compound and servants houses are kept scrupulously clean and inspect periodically to check unauthorised additions to the out houses, and occupation by any outsider of any portion of the building, out houses or even the ground. He will not allow any member of the staff to keep goat or other animals in the premises.
5. The Divisional Forest Officer will operate the Budget of the Forest Rest House including the maintenance of the building and grounds, the cost of the establishment, catering etc. will be prepared by the Divisional Forest Officer and forwarded to the Conservator of Forests for obtaining sanction of the competent authority.
6. These Forest Rest Houses are intended for the use of the Forest Officers on duty.
7. Other Gazetted Officers on duty may also occupy a Forest Rest House if accommodation is available.
8. 8.1 Light and Water charges and Room rent charges will be the same as are applicable in the Public Works Department Rest House of the district.

- 14.1 In Forest Rest Houses, where catering is done, the rates will be fixed by Chief Conservator of Forests / Chief Wild Life Warden.
9. Application for accommodation in Forest Rest House may not be made more than one month before the date on which it is required. The Divisional Forest Officer will allot accommodation to each applicant according to priority of applications but preference will be given to Forest Officer on duty.
 10. A Forest Rest House may not be occupied by an Officer for more than 10 days at one time without the approval of the Divisional Forest Officer concerned.
 11. Officer stationed at places where Forest Rest Houses exist are prohibited from using them except with the express sanction of the Chief Conservator of Forests.
 12. All occupants of the Rest House will make their own arrangement for food.
 13. The table linen, cutlery, crockery etc. are for the use of only those occupying the Rest House. A schedule of charges for breakage will be kept at each House. If any breakages occur the charge according to the Schedule will be realised along with the charges for occupation. Damage done to furniture or any other property will be reported to the Divisional Forest Officer concerned.
 14. A register of the furniture, carpets, crockery, cutlery table linen etc. will be kept in respect of each Forest Rest House showing :-
 - 14.1 the description of each article.
 - 14.2 the date of purchase and authority sanctioning the same.
 - 14.3 the cost,
 - 14.4 the condition on the date of verification each half year
 - 14.5 remarks.
 15. No cooking will be allowed in the rooms or verandas of the main building of the Forest Rest House.
 16. All payment for charges must be made in cash before leaving the Rest House.
 17. No court or meeting of any kind will be held within the premises of the Rest House (except with the written permission of the Divisional Forest Officer)
 18. Any complaints regarding the Forest Rest House arrangements must be put in a Compliant Register which will be kept at each Rest House.
 19. A register shall be maintained at each of the Forest Rest House in the following proforma

Note: The Forest Rest House situated in Wild Life sanctuaries and National Parks will be Managed by the concerned Dy. Chief Wild Life Wardens.

Rates fixed by the State Govt. from time to time will be charged for the Rest House facilities.
