The National Authority, CAMPA invites nominations of eligible and willing IFS officers for appointment in the post for IFS officers in National Compensatory Afforestation Fund Management and Planning Authority as **Assistant Inspector General of Forests (AIGF) [no. of posts-two (02)]** on deputation basis for a period not exceeding five years to assist the Executive Committee in performance of its functions and powers as laid down in the Compensatory Afforestation Fund Act, 2016. The eligibility criteria and other terms and conditions governing the aforesaid deputations will be as per the Central Staffing Scheme of Ministry of Environment, Forest & Climate Change issued vide OM No.A.12011/1/2003-IFS.I dated 06.05.2011.

- 2. The minimum years of service (for the respective posts) will be with reference to 01.01.2024 and the minimum year of service left before superannuation (wherever applicable) will be counted from 01.01.2024.
- 3. It may kindly be ensured that the names of only those officers are sponsored who have completed their "cooling off" period. An officer, who has previously been on any deputation, will be considered for deputation under the Scheme only if the officer has completed mandatory "cooling off" period as per extant guidelines of the Central Government.
- 4. The officers will be posted at Delhi for a period not exceeding 5 years. If the officer selected for appointment fails to take up the central deputation assignment after his/ her appointment is approved, he/she will attract debarment of from central deputation in accordance with the provisions of Central Government.
- 5. Last date of receipt of complete application: The application, complete in all respects as per Annexure-I (available on the website www.ifs.nic.in for different level posts), vigilance clearance, duly attested APARs (in accordance with Scheme) and concurrence of the State Government, should be addressed to CEO, National Authority, CAMPA and sent on email id nationalcampa-moefcc@gov.in latest by 25.11.2024. It may also be ensured that the correct and updated Executive Record Sheet of the applicant is also attached with the application.

- 6. Application received without the consent of the State /UT Government and after the last date of receipt of applications will not be entertained.
- 7. A checklist of documents to be submitted including the application in due format, has been given at Annexure II.
- 8. The State Governments are requested to nominate sufficient number of IFS officers to apply against this vacancy circular.
